To apply for an immigrant visa, a foreign citizen seeking to immigrate generally must be sponsored by a U.S. citizen or lawful permanent resident immediate relative (s), or prospective U.S. employer, and have an approved petition before applying for an immigrant visa.

Step 1: Submit a Petition U.S. citizens and lawful permanent resident petitioners residing in the United States must file Form I-130, Petition for Alien Relative, with the United States Citizenship and Immigration Services (USCIS). After you pay your fees and the status in CEAC is updated to 'PAID', you and each qualified family member immigrating with you must complete the Application for Immigrant Visa and Alien Registration (Form DS-260).
