Every file and directory in Linux has the following three permissions for all the three kinds of owners: Permissions for files. Read – Can view or copy file contents; Write – Can modify file content; Execute – Can run the file (if its executable) Permissions for directories. Read – Can list all files and copy the files from directory
