A port State control visit on board a ship will normally start with, as a minimum and to the extent applicable, examination of the documents in accordance with Annex 10 of the Paris MOU. In addition the PSCO conducts a general inspection of several areas on board to verify that the overall condition of the ship complies with that required by the various Conventions. Info

There are a number of reasons for inspectors to visit a ship, these include: the completion of checks on crew and passenger health; infectious disease control; food hygiene inspections; water and food sampling; assessment of the sanitary condition of the ship; pest control; to inspect cargo and investigate pollution incidents and the issuing of ship sanitation certificates under the International Health Regulations.
